COMMITMENT 1

Step up our response to growing humanitarian needs and help people adapt to the impacts of the climate and environmental crises

Targets

- 1) By 2025, 80% of WHH country strategies will be based on sound* disaster risk analyses
- 2) By 2025, 80% of WHH Country offices (CO) annual programme planning will have annually updated Emergency Preparedness and Response Plans (EPReP) based on sound* disaster risk analyses,
- 3) By 2025, 80% of all WHH recovery and transitional aid projects will be based on systematic learnings from loss & damage caused by the respective crisis and will be based on sound* disaster risk analyses of the respective hazard
- 4) By 2025, WHH will have used its Anticipation & Preparedness Fund (AF) to finance anticipatory humanitarian action in up to 10 projects on a total of 2,0 Mio EUR
- 5) By 2025, at least 44% of all WHH projects will include defined climate resilience (i.e. mitigation, adaptation or preparedness) interventions
- 6) By 2025, WHH will have invested a total of 390,000 EUR to support WHH COs in systematic assessments and analysis for actions , including sound* disaster risk analysis, humanitarian needs assessments, context analysis, conflict analysis.

COMMITMENT 2

Maximize the environmental sustainability of our work and rapidly reduce our greenhouse gas emissions

Targets

- 7) By 2025 WHH will have developed and implemented a sustainability strategy with the mission to act sustainably, care for the people, protect the environment and take everyone along the journey. The strategy will cover the organizational sustainability: WHH's supply chains, investments, resource and waste management, renewable energy supply, fleet and travel management.
- 8) By 2025 WHH will have measured the carbon footprint for all offices, including all fleet, travels, purchased goods and services, commuting, and waste. The project's carbon footprint will be rolled out in 2025.
- 9) We will optimize our fleet management to reduce emissions and pollution in alignment with the following leading Fleet Forum commitments:
 - Within 5 years 25% of vehicles of our organization are Euro3 or higher
 - Within 3 years of our organization participates in vehicle sharing initiatives in at least 20% of the operating countries.
- 10) We will improve our waste management by developing and implementing waste sorting and disposal guidelines by 2026.
- 11) WHH will continue to strengthen its environmental safeguards and application of a standard environmental and climate screening tool for application in Country Offices in at least 150/300 projects until 2025.
- 12) From 2025 on, WHH will assess, reduce and monitor environmental risks in at least 80% of all new projects.

COMMITMENT 3

Embrace the leadership of local actors and communities

Targets

- 12) By 2025, WHH will have implemented its project Localized Multi-Hazard Anticipatory Action Facility Pakistan related to droughts, floods and heatwaves and will have supported other INGO and their local humanitarian partners via its on-going WHH Anticipatory Humanitarian Action Facility (WAHAFA).
- 13) By 2025, WHH and consortia partners will have successfully capacitated 40 Local Humanitarian Partner (LHP) NGOS and through LHP additional local humanitarian peer NGOs in 8 countries via the programme ToGETHER – Towards Greater Effectiveness and Timeliness in Humanitarian Emergency Response.
- 14) WHH will continue to be fully compliant with the Core Humanitarian Standard.

COMMITMENT 4

Increase our capacity to understand climate and environmental risks and develop evidence-based solutions

Targets

15) By 2025, 80% of all WHH program staff will understand and be able to implement environmental safeguards.

COMMITMENT 5

Work collaboratively across the humanitarian sector and beyond to strengthen climate and environmental action

Targets

- 17) As of 2022, we will strengthen/increase our work in partnership with local and national authorities, civil society organizations and development actors to ensure food and nutrition security wherever we work aiming at decreasing the impact on the climate.
- 18) By 2025, we will have undertaken and shared analyses of climate and environmental risks across all geographical locations where we work, informed by primary and secondary data from relevant authorities, including research institutes, government and communities.
- 19) From 2022 on, we will engage in research partnerships to strengthen climate and environmental action and strengthen our collaboration via existing initiatives like the anticipation hub and REAP.

COMMITMENT 6

Use our influence to mobilize urgent and more ambitious climate action and environmental protection

Targets

- 20) By 2025, 80% of WHH Country Offices will have continuously engaged in advocacy towards climate action in national and international processes.
- 21) In 2022 and further, we will engage with our government, and support our partners to speak with their governments, to persuade them to take ambitious climate action, including increasing financial support for locally led adaptation measures.
- 22) By 2025, WHH will have engaged in formulating and launching a minimum of 3 concerted civil society humanitarian action positions for UNFCCC COPs.
- 23) By 2025, 80% of WHH Country Offices will have continuously advocated for awareness, understanding and implementation of International Humanitarian Law protecting the environment, amongst Welthungerhilfe stakeholders in-country.
