Cash Advisory Group (CAG) Briefing to Local and National NGOs (LNNGOs): Application process to become a LNNGO representative or observer on the CAG, 04 September 15:30 – 16:30 CET

The global Cash Advisory Group provides technical support and capacity building for cash coordination at the country level, with the overall aim of enhancing the quality and effectiveness of cash coordination efforts. It currently meets online every 3 weeks and in-person once a year. In September it will be recruiting two new voting LNNGO representatives and two LNNGO observers to the CAG. Global feedback session on the NEAT + (Nexus Environment Assessment Tool), 26 September

The Norwegian Refugee Council (NRC) and the NEAT+ Steering Committee together with practitioners and implementing agencies using the NEAT+ are reviewing the tool – its issues, lessons learned and improvements.

To share challenges, opportunities and way forward for shaping further the dissemination and systematic integration of environmental risks screening into humanitarian response, the Charter Signatories have been invited to join the **Global session on 26 September** from **15:00 – 16:30 CET** that will present the roadmap for the NEAT+'s improvement and sustainability.
