SAVE THE DATE: Mainstreaming and Identifying Funding Sources for Climate and Disaster Risk Reduction in Humanitarian programmes, Thursday, 13 March 2025, 13:00-14:30 UTC / 14:00 – 15:30 CET

There is a growing recognition of the need to integrate – and finance – long-term climate adaptation, DRR, and preparedness measures into humanitarian programming. Learning from organizations that are doing this work, as well as understanding available funding options, can both improve the sector's ability to advance Commitment 1 of the Climate Charter. This webinar co-convened by United Nations Disaster Risk Reduction (UNDRR), the Risk-informed Early Action Partnership (REAP) and the Climate and Environment Charter for Humanitarian Organizations aims to:

- **Raise awareness** among Charter Signatories and the humanitarian sector on the tools and guidance available to mainstream DRR, within Commitment 1 of the Charter.
- Introduce Charter members to different types of financing available, on DRR, EW/EA, and AA, including through case studies
- Explore challenges faced by Charter Signatories in accessing funding for Commitment
 1 and identify support needs for securing funding for climate, environment, and DRR
 activities.
- Synthesize key challenges, concerns and opportunities faced by Charter members related to financing DRR in humanitarian contexts, with *insights to be shared at global* platforms.

FUNDING OPPORTUNITIES

German International Climate Initiative (IKI) Thematic Call, deadline 18 February, 16:00 CET

The IKI Thematic Calls address current challenges in climate action, adaptation and biodiversity conservation on an annual basis. For these challenges, the respective IKI ministries define new thematic priorities as a basis for submission of project outlines. The financing volume provided by the IKI can range from 5 to 20 million EUR per project depending on the thematic priority.

The World Food Programme (WFP) in Afghanistan invites NGOs and nonprofit organizations to submit proposals for resilience-building initiatives aimed at improving food security and agricultural sustainability in the region.

FCDO's OCEAN partnerships grant 2025: Supporting marine environment and coastal communities, deadline 24 March

The UK's Foreign, Commonwealth & Development Office has launched the <u>Ocean Partnership</u> <u>Grants</u> which supports projects led by medium to large organisations that partner with locally led organisations and have the capacity to deliver projects at scale. Projects should deliver local solutions to local problems by partnering with and working alongside local communities and organisations to tackle marine and poverty issues.

Call for submissions: <u>World Water Week: Water for Climate Action</u> 2025, Stockholm International Water Institute

This year World Water Week returns online and on-site at Stockholm Waterfront Congress Centre from **24–28 August 2025**, with the crucial theme <u>Water for Climate Action</u> guiding the discussions. Organizers are now accepting applications for <u>Online Exhibitions</u>, <u>On-site Exhibitions</u>, <u>Closed Meetings</u>, and, new for 2025, <u>Side Events</u>.

Survey: Impact of US aid freeze on CVA

CALP is running a <u>survey</u> to understand how CVA and CVA partners will be affected by the US aid freeze and 28 January waiver to allow "life-saving humanitarian assistance" to continue during the 90 day review period. Responses will be anonymous and only used by CALP staff members for analysis. The summarized data will be used to inform CALP efforts to ensure we make an effective case for CVA to meet the needs of people in crisis.

Consultancy: Climate Expert (Kenya), Kindernothhilfe e.V (KNH): Deadline extended to 20 February

Call of application for the provision of consultancy services to Kindernothilfe e.V. (KNH) for assisting Kenyan partner organizations in addressing climatic-risk factors that exacerbate existing child rights violations in their respective project regions by supporting them in developing strategies to address identified climatic risk factors further threatening the realization of children's rights in Kenya.

International Protection for People Displaced Across Borders in the Context of Climate Change and Disasters: A Practical Toolkit, The Center for Gender & Refugee Studies (CGRS), NSW Sydney's Kaldor Centre for International Refugee Law and the University of Essex's School of Law and Human Rights Centre, with the support of UNHCR, February 2025

This new global resource provides clear and practical legal guidance on international protection claims involving climate change or disasters, based on existing refugee and human rights law and drawing on positive legal precedent in several jurisdictions. The *Toolkit* can be adapted in any country to fit its existing legal framework, much like the <u>practice advisory</u> CGRS created for the United States.

POLICY BRIEFS, REPORTS AND BLOGS

<u>COP16.2: What needs to happen in round 2 of the talks</u>, International Climate Politics Hub (ICPH), February 2025

While the <u>Convention of Parties on Biological Diversity</u> (COP16) held in Cali, Colombia, last November, delivered important outcomes, unresolved tensions over a fund/instrument hindered negotiations. The loss of quorum in the final moments ultimately led to the suspension of the meeting. This brief provides an overview of the key issues at stake and outlines critical messages for this second round of discussion that will take place in Rome from 26 – 27 February.

Future-Proofing Our World: A roadmap to Close the Crisis Protection Gap through Prearranged Finance, High-level Panel on Closing the Crisis Protection Gap, January 2025

A new report from the High-Level Panel on Closing the Crisis Protection Gap, convened by the Centre for Disaster Protection, asks readers to rethink how we prepare for and respond to crises, with a focus on addressing vulnerabilities in crisis-prone regions. The report highlights the need for innovative prearranged finance solutions to enhance crisis protection, especially as extreme weather events grow more frequent.

Resourcing Climate and Health Priorities: Mapping of International Finance Flows 2018 – 2022, Foundation S - The Sanofi Collective, Reaching the Last Mile, and The Rockefeller Foundation January 2025

The report analyzes international finance flows for climate change and health interventions, providing new insights on what finance is available for climate change and health and how is it being deployed, who are the specific funders and funding initiatives available for countries, and specific actions on how to enable increased access to financing for climate and health solutions.

The Global Risks Report 2025, World Economic Forum (WEF), January 2025

The 20th edition of the WEF landmark publication launched last week, reveals an increasingly fractured global landscape, where escalating geopolitical, environmental, societal and technological challenges threaten stability and progress. Once more, the environment ranks high among the greater risks facing humanity with Extreme Weather Events believed to be the second major cause of a large-scale crisis in 2025, as well as one of the most likely risks in the short and long term periods together with biodiversity loss and ecosystem collapse, climate change and earth resources shortages.
